Government Code, Chapter 551, that the Board of Directors of Cypress-Klein Utility District will meet in regular session, open to the public, at 5:30 p.m., on Monday, October 14, 2019, at 15705 North Greenfield Drive, Spring, Harris County, Texas, at which meeting the following items will be considered:
